#### Fund Raising, Gifts, Service Fees:

Albion-Little River Volunteer Fire Department, Inc received \$200 (\$315 net) from the Little River Inn concert series.

#### **Development:**

- Began issuing pulse oximeters to firefighters (after switching from \$275 model to sub-\$25 FDA approved model).
- Began issuing blood pressure sets as a training tool.
- Issuing Essentials of Fire Fighting and Fire Department Operations to all firefighters.
- The district lacks functioning draft systems for filling engines/tenders both at scene and at stations. In recent times, suctioning from station tanks has been discouraged due to a previous tank collapse. Gravity fill is slow it can take greater than half an hour to fill a tender from a station tank. We are working on solutions. Jaime Placido has volunteered to install proper vents on the station tanks so that apparatus pumps can be utilized. Brad Montgomery plans to build and stock draft lines for our fleet.
- Tim Gitchel (a certified marine mechanic) and Adam Matthews created an inventory of our boat equipment. There is demand for water trainings. We plan to start by sending our interested firefighters to Mendocino's water trainings.
- As requested by the district board, Ted Williams researched the LiveScan application process. A form with instructions for special districts is available at <a href="http://ag.ca.gov/fingerprints/forms/city">http://ag.ca.gov/fingerprints/forms/city</a> county.pdf
- Dirk Dooley (Mendocino Fire) has offered assistance with the SCBA fit test. We need to fit test our firefighters annually.
- o Ted Williams has been investigating Compressed Air Foam Systems as a possible ingredient in our long term plan.
- Sally Swan (Mendocino Fire) has invited us to send a group to Mendocino on January 21, 1100 at station 840, to watch Mendocino's pump training.
- Kent Stanley (Mendocino Department of Transportation) came to look at the road condition outside station 810. Based on maps, he concluded that the road is not a county road. Ted Williams was not able to find an APN for the road. Board member Ed Petrykowski has taken an action item of resolving ownership of the road.
- Ted Williams talked to a district property owner regarding a new district assessment. I believe the district needs to clarify that the assessment is for legal parcels and not simply APNs (which can be created simply for ease of mapping).
- Engine 8170, the USDA Forest Service type III engine, was placed in service. There will be some shuffling while vehicles are exchanged with Fort Bragg Diesel for repair, but we anticipate the near term home for this engine to be station 812.
- Our TODO lists are long. Safety and training are taking priority.
- It should be noted that the ALRVFD, Inc covered hotel stay and meals for the nine firefighters who attended the 40 hour Driver/Operator 1A course in Ukiah.
- A CalFire Model 11 type III engine (1200 gallon + foam) has become available for approximately \$3,000. District
  firefighters have been discussion this vehicle and how it would fit the Navarro Ridge / station 815 component of the
  long term plan. The discussion should continue between firefighters and the district board.
- District firefighters have been discussing a 1200 gallon type III engine available from CalFire for approximately \$3,000 as a potential upgrade for station 815 (Navarro Ridge).

#### **Station Maintenance**

The standby generator at station 810 is not functional. The board should provide guidance as to whether to pursue repair.

- Mendocino Coast Water Works provided a written cost estimate for plumbing repairs at station 810. \$1985 includes "Cost estimate for re- pipe of failing drainage system on west side of building. Scope of work to include replacement of 2" cast iron for kitchen sink, laundry, and lavatory sink. New piping to extend to existing connections underneath. \*Additional quote supplied for new gas service from tank to entry for kitchen. Gas run underground with new shut off."
- Mendocino Coast Water Works discovered an above ground propane line hidden in the grass. An estimate of \$675
  was offered for "Trenching, Pipe, Labor" to remedy.

Dear Albion-Little River Volunteer Fire Department,

The Albion Residents Association would like to comment on the recent discussion regarding a new fire house at the foot of Albion Ridge Rd. We have been involved in the protection of the Albion coastal zone for many years and often comment on coastal development permit proposals before and during the county hearings. New structures in the coastal zone are examined very closely by the County and the California Coastal Commission before approval.

While we do support the local Fire Department with contributions and taxes, we believe that the proposal of a new fire house on Albion Ridge Road opposite the Albion Grocery is not a good idea, for the following reasons:

- 1) The land designation in the General Plan is rangeland. Although there are several small parcels in the area, none of them is large enough to hold a major facility. The Fire Department would have to go through a General Plan amendment, a zoning change, and boundary line adjustments to get a parcel adequate for the purpose. This process could add tens of thousands of dollars to any proposal and would probably be contested, adding more expense.
- 2) The area is designated "highly scenic" in the Local Coastal Plan. There are very strict height limits in the "highly scenic" zone, which would probably restrict the building height to less than would be possible outside the Coastal Zone. Albion residents have opposed the encroachment of buildings into the viewshed. This particular site, opposite the store, would intrude on the pleasant view of the pastures that is the one attractive view from the town. A huge building and parking lots would degrade the character of the town, dominating the smaller buildings and miniscule parking lot.
- 3. The traffic situation near the store is extremely congested. A driveway for fire trucks would increase the congestion, be a traffic hazard and hinder the actions of the firefighters both arriving and exiting the driveway.
- 4. The Fire Department has land that can be used to extend the current firehouse in Albion, and another in Little River. It would be preferable to see any expansion of the facilities centered on these two sites rather than concentrating them in the Albion coastal zone.

- 5. The property tax assessment for the Fire Department was passed recently and residents are unlikely to pass any additional taxes for this purpose. The current building fund cannot accommodate the very high cost of building a new facility and the costly land use planning changes that would be necessary.
- 6. The addition of a proposed "community center" to the facility would only increase the size and cost of the building, parking, staffing, insurance and maintenance with no plans for running the center after it was built.

Please notify us of agenda items that relate to this proposal so that we may participate. Thank you again for everything you do to keep our community safe.

Hello Lloyd,

Per our telephone conversation this morning please find the attached documents pertaining to changes to fiscal operations of the Albion Little River Fire Protection District as we discussed and as follows:

#### 1. SB 288 changes to California Government Code section 53952 and 53961.

In a telephone conversation we had in October we discussed the requirements to implement the changes to allow a greater amount of the district budget to be kept in the revolving fund. At our regular business meeting on October 25, 2011 the board of directors of ALRFPD passed a resolution (certified copy attached) authorizing deposit of district funds into the revolving fund in an amount not to exceed 110% of 1/12<sup>th</sup> of the district's adopted budget for the current fiscal year.

You have advised us that for the purposes of calculation we may only include the budget items in "Services and Supplies" categories in our total FY budget (excluding employee expenses and capital expenses) to determine the maximum amount allowed in the revolving fund. Per our revised approved FY 2011-2012 budget (certified copy attached) approved at our December 8, 2011 regular business meeting the maximum amount allowed in the revolving fund would be 110% of  $1/12^{th}$  of \$135,000 = \$12,375. Currently we have an allowance for a maximum amount of \$3,000 to be held in the revolving fund. If the attached documentation is adequate we will provide a letter of request for a warrant for the difference (\$12,375 - \$3,000 = \$9,375) to deposit into the district revolving fund checking account.

#### 2. Signature requirements for district accounts.

At our regular business meeting on November 29, 2011 the board of directors adopted revised bylaws (certified copy attached, certified approved minutes attached) which, among other changes, reduces the number of signatures required to authorize checks, warrants, and vouchers from two to one. Each of the members of the board of directors and the bookkeeper are authorized signers for each district account. Please note the changes and be advised that from now on vouchers will have a single signature.

Please let me know if you have any questions or if there are any issues with these changes. I would appreciate a timely response so that we may implement these changes as soon as possible. Our next regular business meeting is scheduled for January 12, 2012.

- Began issuing pulse oximeters to firefighters (after switching from \$275 model to sub-\$25 FDA approved model).
- Began issuing blood pressure sets as a training tool.
- Issuing Essentials of Fire Fighting and Fire Department Operations to all firefighters.
- o The district lacks functioning draft systems for filling engines/tenders both at scene and at stations. In recent times, suctioning from station tanks has been discouraged due to a previous tank collapse. Gravity fill is slow it can take greater than half an hour to fill a tender from a station tank. We are working on solutions. Jaime Placido has volunteered to install proper vents on the station tanks so that apparatus pumps can be utilized. Brad Montgomery plans to build and stock draft lines for our fleet.
- o Tim Gitchel (a certified marine mechanic) and Adam Matthews created an inventory of our boat equipment. There is demand for water trainings. We plan to start by sending our interested firefighters to Mendocino's water trainings.
- As requested by the district board, Ted Williams researched the LiveScan application process. A form with instructions for special districts is available at <a href="http://ag.ca.gov/fingerprints/forms/city\_county.pdf">http://ag.ca.gov/fingerprints/forms/city\_county.pdf</a>
- Dirk Dooley (Mendocino Fire) has offered assistance with the SCBA fit test. We need to fit test our firefighters annually.
- o Ted Williams has been investigating Compressed Air Foam Systems as a possible ingredient in our long term plan.
- Sally Swan (Mendocino Fire) has invited us to send a group to Mendocino on January 21, 1100 at station 840, to watch Mendocino's pump training.
- Kent Stanley (Mendocino Department of Transportation) came to look at the road condition outside station 810. Based on maps, he concluded that the road is not a county road. Ted Williams was not able to find an APN for the road. Board member Ed Petrykowski has taken an action item of resolving ownership of the road.
- Ted Williams talked to a district property owner regarding a new district assessment. I believe the district needs to clarify that the assessment is for legal parcels and not simply APNs (which can be created simply for ease of mapping).
- Engine 8170, the USDA Forest Service type III engine, was placed in service. There will be some shuffling while vehicles are exchanged with Fort Bragg Diesel for repair, but we anticipate the near term home for this engine to be station 812.
- Our TODO lists are long. Safety and training are taking priority.
- It should be noted that the ALRVFD, Inc covered hotel stay and meals for the nine firefighters who attended the 40 hour Driver/Operator 1A course in Ukiah.
- A CalFire Model 11 type III engine (1200 gallon + foam) has become available for approximately \$3,000. District
  firefighters have been discussion this vehicle and how it would fit the Navarro Ridge / station 815 component of the
  long term plan. The discussion should continue between firefighters and the district board.
- District firefighters have been discussing a 1200 gallon type III engine available from CalFire for approximately \$3,000 as a potential upgrade for station 815 (Navarro Ridge).
